

DEED OF GIFT

THIS DEED OF GIFT IS MADE THIS THE 2016 DAY OF JULY 2009.

Between

SRI SANDIP KHAN, Son of LATE SUNIL KUMAR KHAN, by religion Hindu, by occupation Business, Nationality Indian, residing at Kadamtala, Jalpaiguri Town, Police Station Kotwali, Post Office & District Jalpaiguri, hereinafter called the "DONOR" (which expression shall mean and include unless excluded by or repugnant to the context his heirs, successors, executors, administrators, representatives and assigns) of the ONE PART.

<u>AND</u>

JALPAIGURI DOOARS PRIMARY TEACHER'S TRAINING INSTITUTE, having its Registered Office at Village & Post Office Ghagra, Police Station Alipurduar, District Jalpaiguri, duly represented by its President hereinafter called the "DONEE" (which expression shall mean and include unless excluded by or repugnant to the context its executors, administrators, representatives, successors-in-office and assigns) of the OTHER PART.

WHEREAS, the Donor has acquired title by way of purchase the land measuring 0.65 acres fully described in the Schedule below, by virtue of Two Registered Deeds of Sale, (1) Being No. 362, dated 02/02/2006, registered at Additional District Sub-Registry Office Alipurduar, being purchased from Sri Supen Ghosh, Son of Late Narendra Ghosh, residing at Village & Post Office Ghagra, Police Station Alipurduar, District Jalpaiguri, and (2) Being No. 635, dated 15/02/2006, registered at Additional District Sub-Registry Office Alipurduar, being purchased from Smt. Rani Bala Dey, Wife of Late Amulya Chandra Dey, residing at Village & Post Office Ghagra, Police Station Alipurduar, District Jalpaiguri, and since the date of such purchase the Donor has been enjoying and possessing his said purchased landed property peacefully as sole and absolute Owner thereof.

AND

WHEREAS, the Donor have permanent, exitable and transferable right, title and interest in the said land and the same is not subject of any Acquisition or Requisition proceedings under any Law or Enactment now in force.

AND.

WHEREAS, the Donee is an institute for training purpose of the Teachers and the Donor who has deep affection for the said purpose of the Donee, and the Donor in consideration of such affection has firmly and finally decided to make Gift of all that piece or parcel of land measuring 0.65 acres as fully described in the Schedule appended below (hereinafter referred to as "THE BELOW SCHEDULED LAND" for the sake of brevity) out of his (Donor's) aforesaid total land, free from all encumbrances and charges whatsoever, and the Donee have also agreed to accept the said Gift of the Donor.

NOW THIS INDENTURE WITNESSETH, that in pursuance of the aforesaid desire & decision of the Donor and in consideration affection which the Donor has for the Donee, the Donor out of his free will and without any fear, fraud, coercion, pressure or undue influence from anybody, does hereby give, grant, transfer by way of Gift his (Donor's) said below Scheduled land absolutely and for ever and makes over possession thereof unto and in favour of the Donee TO HAVE AND TO HOLD the same by the Donee as absolute Owner thereof, together with all right, title interest, hereditaments, liberties, trees, paths, fences etc. whatsoever in any way belonging to or reputed to belong therewith, peaceably and quietly, with permanent heritable and transferable right, and without any claim, objection,

interference or interruption from the Donor or any person or persons claiming under him, subject to the payment of Land Revenue and other taxes to the Superior Landlord now the Govt. of West Bengal.

The Donor declares that he shall not hereafter revoke/cancel this Gift and/or this Deed of Gift. Any such act or attempt in future by the Donor shall be void and not maintainable in Law.

The Donor further declares that he has not previously transferred, mortgaged or contracted for sale or otherwise the said below-schedule land hereby transferred by way of Gift in favour of any other person or party, and that the Donor does hereby make this Gift of his said below-scheduled land hereby transferred by way of Gift in favour of any other person or party, and that the Donor does hereby make this Gift of his said below-scheduled land of the value of Rs. 1,78,000/- (Rupees One Lakh Seventy Eight Thousand) only, in favour of the Donee hereof, free from all encumbrances & charges whatsoever.
