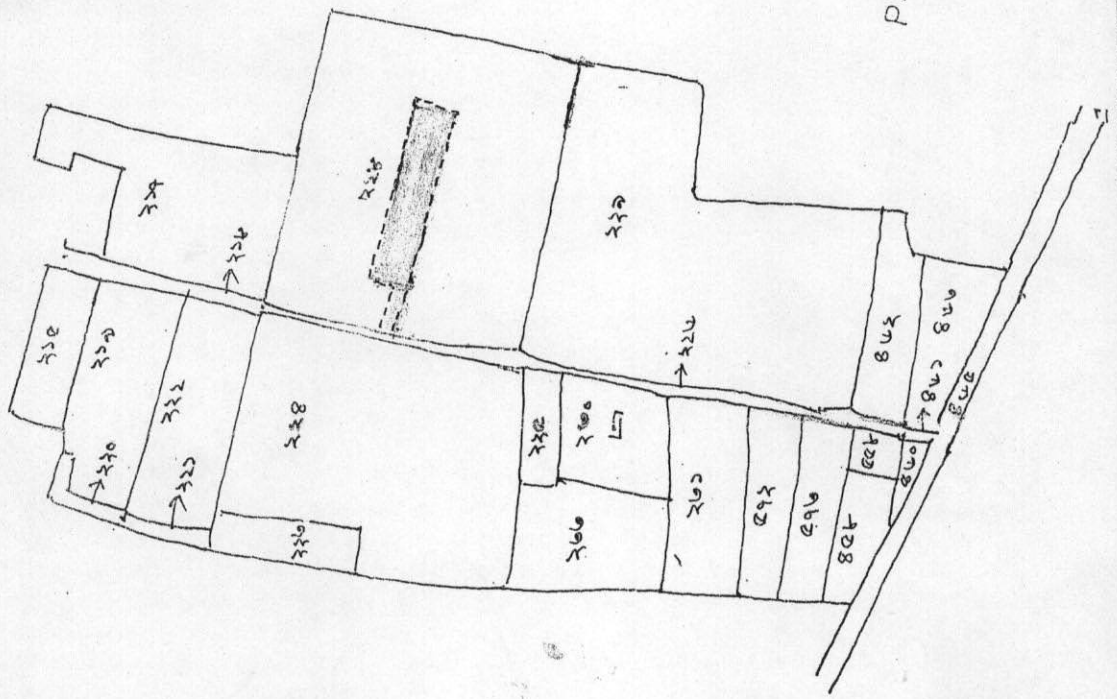
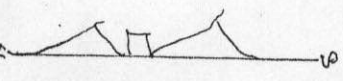


PART TRACE MAP OF - MOUZA - GHAGRA
